

## Portfolio description

The primary objective of a retirement fund is to replace one's salary on retirement. This may vary from individual to individual, depending on his/her needs and circumstances.An AF LifeStage retirement solution is a dynamic investment strategy designed towards achieving this objective. The AF LifeStage solution has 2 distinct phases: Accumulation of assets (30-40 years), and preparing towards retirement (5-7 years prior). The AF Passive Protector Fund is designed for the preparation for retirement phase.


