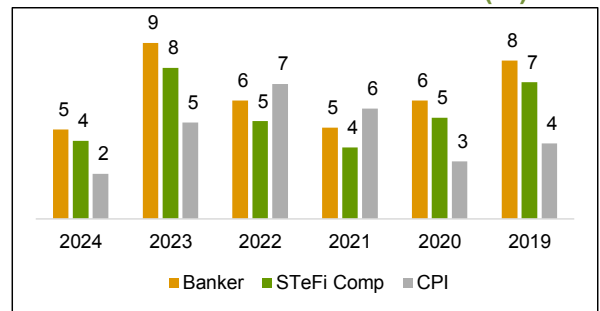
### About the portfolio
